The Club had a brief discussion on banners for seniors, and sponsors for programs.

Ken & Dale will be looking into hanging the plaques from the senior scholarship winners.

**Scoring Building/Dugouts/Sound System:** Dale commented that the backside of the field still needs to be concreted, and the fence still needs to be fixed. Concerns about the gate being unlocked along with the bathroom doors being unlocked and lights on.

Ken mentioned that he would like to pursue upgrading bleachers.
